## TERMS AND CONDITIONS OF BOOKING WITH INTERNATIONAL VENTURES, LTD.

## Reservations, prices and payment:

Deposit (s): A \$200 per person deposit, along with the completed Tour Registration form, is required to request your reservations. On confirmation, a 20% deposit is immediately due to hold your reservations confirmed until time of final payment. Final payment is then due 60 days prior to departure.

An administrative fee of \$75 may be charged for bookings received within 60 days of the departure date. Any change to the reservations is subject to a \$50 fee per person per change. Please note: some of our local operators have payment schedules that differ from the above. Should they differ you will be advised at time of booking.

**Cancellation of land tour:** Cancellations must be received in writing. Any deposits received are non refundable. Up to 60 days before departure: Deposit(s) is forfeited.

59 – 35 days before departure: 50% of safari cost is forfeited

34 – 15 days before departure: 75% of safari cost is forfeited

14 days or less before departure: 100% of safari cost is forfeited

Please note: some of our local operators have cancellation fees that differ from the above. Should they differ you will be advised at time of booking and the higher fees prevail.

**Cancellation of air transportation:** The cancellation fees for air transportation vary per carrier and applicable fares. The cancellation fees are in effect only after ticketing.

**Insurance**: International Ventures, Ltd. strongly recommends purchasing insurance for trip cancellation, injury, illness and loss of effects. A complete tour package, underwritten by Travel Guard International, is available.
